INTERIM ORDER

(Admitting the Complaint/Petition and Fixing Date of Hearing)

1. The present complaint/petition has been filed by Shri Ram Fabrics against SDO 'Op' Sub Division Sub Urban No. 1, DHBVN & Anr. under section 142, read with section 146 & 149 of the Electricity Act, 2003 & Regulation 2.32 of HERC (forum & Ombudsman) Regulations,

2020, on account of Non-Compliance of order dated 08.09.2023, passed by CGRF -DHBVN, Gurgaon directing refund of FSA charged after 30.07.2021 and refund of Electricity Duty (ED) as per Nigam instructions. Despite the order, compliance was not made. Consequently, the petitioner filed a complaint on the DHBVN portal on 09.08.2024. Due to non-redressal within the prescribed period under the Right to Service Act, 2014, the petitioner filed Appeal No. AAS24/1220959 on 22.08.2024. The matter was heard by the Second Grievance Authority on 28.10.2024 and again on 12.11.2024. Vide order dated 22.11.2024, the Authority directed grant of exemption from Electricity Duty under Sales Circular No. 20/2018 for ten years from the Date of Commercial Production (11.11.2016 to 11.11.2026). As the respondents failed to implement the directions, the present non-compliance petition was filed before the Commission on 30.06.2026. Accordingly, the complaint stands **admitted** for consideration.

2. **In view of the above, the matter is fixed for hearing on 25/08/2026 at 11:30 A.M.** before the Commission. The parties shall be duly informed and required notices, as per procedure, should be issued for their appearance.
3. The Respondent No. 1 & 2 are directed to **appear in person** on the date so fixed and **shall submit a compliance report** on the AAS24/1220959 order dated 22.11.2024 before the date fixed for hearing with an advance copy served to the complainant/ petitioner.
4. The present order shall be uploaded on the official website of the Commission for the information of all concerned.
