CLARIFICATION ORDER

In view of the apparent inconsistency between the operative directions and the reasoning recorded in the decision rendered in Appeal No. 14/2026, it is hereby clarified and directed as under:

The claim preferred by the complainant, insofar as it falls outside the period of limitation prescribed under Clause 2.8.1(i) of the Haryana Electricity Regulatory Commission (Forum and Ombudsman) Regulations, 2020 (as amended from time to time) — which mandates that a complaint or representation shall be preferred within two years from the date of the cause of action — stands barred by limitation and is, therefore, not maintainable before the Electricity Ombudsman.

Consequently, the said claim is held to be outside the jurisdiction and adjudicatory ambit of the Electricity Ombudsman and is declined. The Point No 3 of the Decision part and subsequent Point (ii) of the operative directions contained in the said order shall stand omitted and treated as non-existent. All other findings, observations, and directions recorded in the decision shall remain undisturbed and shall be read in consonance with Point 2 of the decision portion of the order being an overriding Point upon the omitted Points as mentioned above for sake of clarity.

This clarification shall form an integral part of the order dated 03.08.2026 passed in Appeal No. 14/2026 and shall be read accordingly.
